Employees must not accept gifts from any source without prior approval from the relevant General Manager. All donations, gifts, hospitality or sponsorship must be declared. Employees must not solicit or accept gifts from patients, suppliers, or other providers without the prior approval of the Chief Executive. Including any offer to provide or fund travel, accommodation, attendance at and conference fees, grants, gifts, donations or corporate hospitality

Exceptions are those items or offers of minimal value such as:

- boxes of chocolates
- minor industry give-aways (pens, calendars, calculators, diaries etc)
- a bunch of flowers

No notifications or declarations have been received during the 2018/2019, 2019/20, and to date in the 2020/21 financial year.
